### WHAT DO I NEED TO ENROLL?

Have this information for yourself and anyone in your household applying for insurance: (if applicable)

- Social Security numbers
- Visa, green card or immigration documents
- Most recent tax return
- Employment information
- Current insurance coverage

#### Important

You may need to provide documents to confirm details in your application, like citizenship and income. You are required to provide documents verifying your Qualifying Life Event to obtain coverage.

If you do not enroll in healthcare coverage

**you could pay a \$695 Tax Penalty\***

\* Per person, up to a maximum of three people in your tax household, or up to 2.5% of your family's Modified Adjusted Gross Income (or MAGI) if that amount is higher.

To enroll outside of Open Enrollment, you must have a Qualifying Life Event (QLE) to receive a Special Enrollment Period (SEP). These Qualifying Life Events (QLE) include:



Moving to CT



Turning 26 years old and losing coverage from parent



Loss of coverage due to loss or change in job



Marriage



Divorce or Legal Separation



Having, adopting, or fostering a child

You have 60 days from the date of your Qualifying Life Event (QLE) to enroll or make a change. You are required to provide documents verifying your QLE to obtain coverage.
